The undersigned volunteer, in consideration of participating in any and all horse, cat or general farm related activities, hereby forever releases and discharges The Foxy G Foundation (Foxy G), its officers, directors, agents, volunteers, advisors and/or representatives in any location where these activities are conducted or horses or cats and/or property are used from any and all claims, rights, demands, actions, causes of action, expenses and damages of any kind which he or she may ever have, whether known or unknown. The undersigned further understands the risk involved in participating in volunteer activities to include serious injury or death and fully assumes said risk for any injury, loss or damage of any kind resulting from such associated activities. It is further understood that all volunteers should maintain a policy of insurance covering medical treatment and all related costs in the event of an injury as a result of participating in any and all Foxy G activities and that should said volunteer choose not to maintain a policy of insurance that they are liable for medical treatment and all related costs in the event of an injury as a result of participating in any and all Foxy G activities. Volunteers hereby agree to assume all expenses, medical, liability, or otherwise, arising out of any injury to them while participating in any activity or event either at Foxy G or elsewhere and understands that Foxy G does not provide health, accident, or liability insurance to participants in any related activities.

I acknowledge that I must treat the horses, cats and fellow volunteers with respect and dignity and under no circumstances will any form of abuse be tolerated against any animal or person, be it physical, verbal or otherwise, and should said referenced events occur I will be asked to leave and will no longer be eligible to participate in any Foxy G volunteer activities. The person executing this Release acknowledges that there is a valid consideration to executing this Release. The invalidity of any statement or waiver of rights above under local, state or federal law does not invalidate any other statement or waiver of rights above and have read, fully understand and voluntarily agree to this Release and that no oral representatives, statements or inducements apart from this Release have been made to me.

In the event that emergency medical aid/treatment is required by me for illness or injury while on any Foxy G property or participating in any Foxy G related activity _____ I DO _____ I DO NOT authorize Foxy G to secure and obtain medical treatment and/or transportation if needed.
